2. The General Secretary, Shaheed Bhagat Singh Educational & Welfare Society has applied for establishment of a nursing institute named as Shaheed Bhagat Singh College of Nursing, V.P.O. Mehal Kalan, Barnala, Punjab. On careful consideration of the proposal, the Government of Punjab has decided to issue an essentiality certificate/No Objection Certificate to the applicant starting **ANM Nursing Course with an intake of 60 seats** with the following conditions:-

- (i) The Institute shall obtain recognition/ affiliation from the Punjab Nursing Registration Council as applicable.
- (ii) The Institute would get affiliation with the concerned University/Board as the case may be before making the admission.
- (iii) No admission shall be made without the prior approval of Punjab Government for which the institute would make a separate application after putting up the requisite Building infrastructure/ Machinery & Equipment/ Staff/ Hostel etc. as per norms.
- (iv) The admissions, fee structure and reservation of seats shall be as per Punjab Government instructions and policies issued from time to time.
- (v) The pay scales and emoluments of their staff shall be as per Punjab Government pay scales.
- (vi) The inspection of the institute shall be carried out on yearly basis up to the completion of the study of first batch of the students. Therefore, the inspection shall be periodical after three years.
- (vii) The project is to be implemented as per the approved project report within prescribed time.
- (viii) The Institute shall all times abide by the condition laid down by the Punjab Govt./ Council/ University etc.
- (ix) The Institute will deposit the Change of Land (C.L.U.) certificate issued by Department of Housing and Urban Development, Punjab within 6 months to the State Government.
- (x) The institute will deposit the earnest money to the State Government within six (6) months as per guidelines issued by this department and letter issued in continuation of these guidelines time to time and shall deposit endowment funds as required by competent authority.
- (xi) The Punjab Government will have the right to withdraw the No of it.
- (xii) The construction Work shall be completed within one year and admission shall be made within 2 years of the issue of NOC. The institute shall be allowed to make admission only if it constructs its own building on the proposed land.

(xiii) The Institute shall abide by provision of Punjab Private Health Sciences Educational Institution (Reservation and admission fixation of fee and making reservation) Act, 2006.

(xiv) If the above conditions are not fulfilled by the concerned society/ applicant in time then it will be the responsibility of the Director, Medical Education and Research, Punjab to inform the Government in time. Amount deposited by the institute will be forfeited in case institute fails to comply with conditions of the Essentiality certificate.
